## Our Work for You

- Provided emergency COVID support to our region's business community  
*Deployed \$4 million quickly to businesses that were struggling with the economic impacts of COVID-19*
- Facilitated loans in excess of \$5 million across all three counties in our region
- Secured \$14 million in grants for redevelopment efforts in our region
- Coordinated site selection and expansion opportunities for the region, which has resulted in an international company choosing our region for a new facility, adding 1000 jobs
- Provided service to 100 inquiries in the past 2 years from businesses and their consultants considering locating or expanding in our region
- Convened our 9-county southcentral PA region in developing an economic development strategy that will open the potential for additional federal funding through the Economic Development Administration
- Finished brownfield study of the HARSCO brownfield site, increasing its value to the Cameron Street Corridor



## Continuing Impact

- Finalize 9-county comprehensive economic development strategy and begin implementation of initial goals
- Partner with Visit Hershey Harrisburg on a reinvigorated economic development marketing and talent attraction strategy
- Convene our downtown groups into a regional downtown collaborative to examine best practices and explore other collaboration opportunities
- Begin deployment of the Pennsylvania Catalyst Fund, which has the potential to lend close to \$4 million to disadvantaged businesses in the region
- Work with Impact Harrisburg on the implementation of the recommendations from the City of Harrisburg's disparity study
